- National Drinks (soft drinks, beer, wine, house drinks, cocktails, and coffee) during the hours of bars and restaurants.
- National drinks in the mini-bar (water, soft drinks, beer).

### Cancellation Policies

In the case of a cancellation which cannot be substituted by another person, the following nonrefundable fees will apply. Substitutions are authorized only in the case that there are no changes to the rooms.

In case of cancellation Dec. 1, 2010-July 31, 2011, the fee is \$300.00USD.

In case of cancellation Aug. 1, 2011-Jan. 31, 2012, the fee is \$600.00USD.

**Cancellations after Feb. 1, 2012 are considered NO SHOWS and have a cost of \$1,650.00 USD for doubles and \$2,500.00USD for single rooms.**

**Due to the oil spill in the Gulf of Mexico, in the case of the beaches being closed for contamination, the hotel agreement includes the possibility to reschedule the event respecting the prices.**

**Not included:** Plane tickets, Imported drinks, purchases, and non-included waters sports. Participants will open an account upon arrival leaving a deposit or opening a credit card tab to be paid by the individual at check out in the case of the use of non-included services.

Telephone calls (including 800 numbers for prepaid phone cards), consult the prices with the operator. Room service, box lunch, laundry service, Spa, Beauty Salon, Purchases and services available at the stores located within the hotel.

**Luggage:** Each piece of luggage should be clearly identified with the owner's name and LQP.

### Participant Room List

The finalized room list of participants with the room type (single or double) **is required no later than November 1, 2011.**





General conditions of agreement between QUALITY PROJECT, S.A. DE C.V. (LQP) and \_\_\_\_\_ Passport number \_\_\_\_\_ (CLIENT).

1. LQP declares that the services it offers correspond to an intermediary for the tourist services, directly between the CLIENT and the service providers.

2. LQP declares that the present offer is exclusively for active members of LIFE QUALITY PROJECT INTERNATIONAL and its affiliates worldwide, all of whom are subject to LQP approval.

3. The CLIENT is required to follow the rules and conditions for the established services for each and every LQP contracted service provider, relieving LQP from any responsibility incurred by the incompleteness of the conditions or regulations.

4. The CLIENT is responsible for providing passports or required immigration documents by the authorities of the United States of Mexico and all countries of transit or destination, including visas, health permissions, etc. In the case of international travel the CLIENT is required to present required documentation at the airport three hours prior to the scheduled departure for international flights and two hours prior to departure for national flights except in the case of expressed written instructions and received by LQP.

5. The CLIENT recognizes and accepts his/her complete obligation and responsibility to relate accurate information about legal names, ages, sex, of the users-tourists as this information is used for itineraries and reservations of the offered services.

6. The CLIENT must punctually make payments as per indicated above. In the case that payments do not meet the requirements stated above, the indicated cancellation fees will be applied.

7. Both parties require the deposits and final payment for the services to be made by the CLIENT and therefore the use of this contract, coupons, tickets, courtesy tickets or any other documents in favor imply the complete acceptance of the conditions of this contract.

8. The CLIENT agrees that due to the minimum number required to obtain the benefits of this offer, in case of cancellation the following fees need to be paid by the CLIENT.

- Cancellations from December 1, 2010 to July 31, 2011 have a cancellation fee of \$300.00USD
- Cancellations from August 1, 2011 to January 31, 2012 have a cancellation fee of \$600.00USD
- Any cancellation made on or after February 1, 2012 is considered a NO SHOW and has the cancellation fee of \$1,650.00USD per person for double room and \$2,500.00USD for single room.

9. The CLIENT may request substitutions of people (active members of Life Quality Project International and their affiliates), who will be subject to the rules and regulations of LQP, as long as it does not imply a change in room or any conflict of interests for LQP.

10. The CLIENT understands and accepts that the offer is based on a minimum of 1,000 adult participants in double rooms. LQP will advise before December 15, 2011 whether or not the minimum number has been completed. In the case of fewer than 1,000 people, the costs may increase without changing the agreement or the cancellation fees stated above unless authorized explicitly by LIFE QUALITY PROJECT, S.A. DE C.V. (LQP). LQP reserves the right to retain payments made, considering the corresponding cancellation fees that may have been accrued.

11. LQP is not responsible for injuries, accidents, or irregularities that occur by natural causes or forces of nature or of an accidental nature during the execution of services that could result for the CLIENT. LQP is not directly responsible for providing related services and is functioning only as the intermediary between the service providers and the customer; this also considers cancellations due to unfavorable ecological or climatic conditions.

12. LQP is not responsible for any additional agreements made between the CLIENT and service providers such as air and ground transportation, boats, cruises, hotels, rented cars, etc.

13. Both parties recognize that the present conditions are governed by the services offered; accepting that all unforeseen will be determined by the laws of the United States of Mexico, subjecting the both parties to the jurisdictions of the city of Mexico, D.F. resigning the right to jurisdictions in the present or future home country.
